

THENCE with said east R.O.W. N07°44'43"E 60.00 feet to a found 1/2" iron rod for the most westerly northwest corner of this tract and being the southwest corner of Lot 3 of the Highnote Subdivision recorded in Volume 7, Page 192, Plat Records of Navarro COunty, Texas;

THENCE $882^{\circ}20'23''$ E 513.16 feet to a found pipe post for an ell corner of this tract and the southeast corner of said Lot 3;

THENCE N07°41'31"E 340.49 feet to a found pipe post for an angle corner of this tract and the northeast corner of Lot 2 of said Highnote Subdivision;

THENCE N13°23'51"W 106.59 feet to a found axle for the most northerly northwest corner of this tract;

THENCE with the line of directional control N60°00'00"E 659.74 feet to a found highway monument for the northeast corner of this tract located in the proposed southwest R.O.W. of State Highway 31 (Loop);
