## NAVARRO COUNTY

All of that certain lot, tract, or parcel of land situated in the James W. O'Brian Survey, Abstract 632, Navarro County, Texas, being part of a called 640.0 acre tract described as Tract One in a deed from The University of Texas System to CRH Investment Company, Ltd. recorded in Volume 1487, Page 833, Deed Records of Navarro County, Texas. Said tract being more fully described by metes and bounds as follows.

BEGINNING at a ½" iron rod found for the southeast corner of this tract, on the south line of the aforementioned called 640.0 acre tract, the southeast corner of said tract bears a called N59°23'32"E 1058.91 feet;

THENCE S59°23'32"W with the south line of the aforementioned called 640.0 acre tract, at 701.09 feet to a ½" iron rod found for the southwest corner of this tract, also being on the east right of way of the Trinity and Brazos Valley RailRoad;

THENCE with the east right of way of the Trinity and Brazos Valley RailRoad as follows: N43°05'00"W 150.41 feet, N46°15'11"W 212.83 feet, N50°58'04"W 261.02 feet, N53°44'26"W 369.87 feet and N54°18'37"W 128.81 feet to a ½" iron rod found;

THENCE N30°00'00W with the west line of this tract at 1840.06 feet to a ½" iron rod found for an ell corner of this tract;

THENCE N60°05'27E with a north line of this tract at 500.12 feet to a ½" iron rod found for an ell corner of this tract;

THENCE N30°01'38"W with a west line of this tract at 918.38 feet to a ½" iron rod found for the most northerly northwest corner of this tract in County Road No. NW1090;

THENCE N60°04'54"E with County Road No. NW1090 and the north line of this tract at 589.90 feet to a ½" iron rod found for the northeast corner of this tract;
